It has developed and now manages a supported living community in Sonoma, California. This model includes an enrichment program intended to foster both individual choice and community engagement to provide a "life with purpose". As part of this community integration effort, we operate a one acre farm, located right on our campus, and our Sweetwater residents participate in the process. We grow a variety of vegetables, using sustainable practices, all year round. Our residents plant, maintain and harvest our crops and help operate our weekly farm stand. We also "give back" by donating some of our produce to community

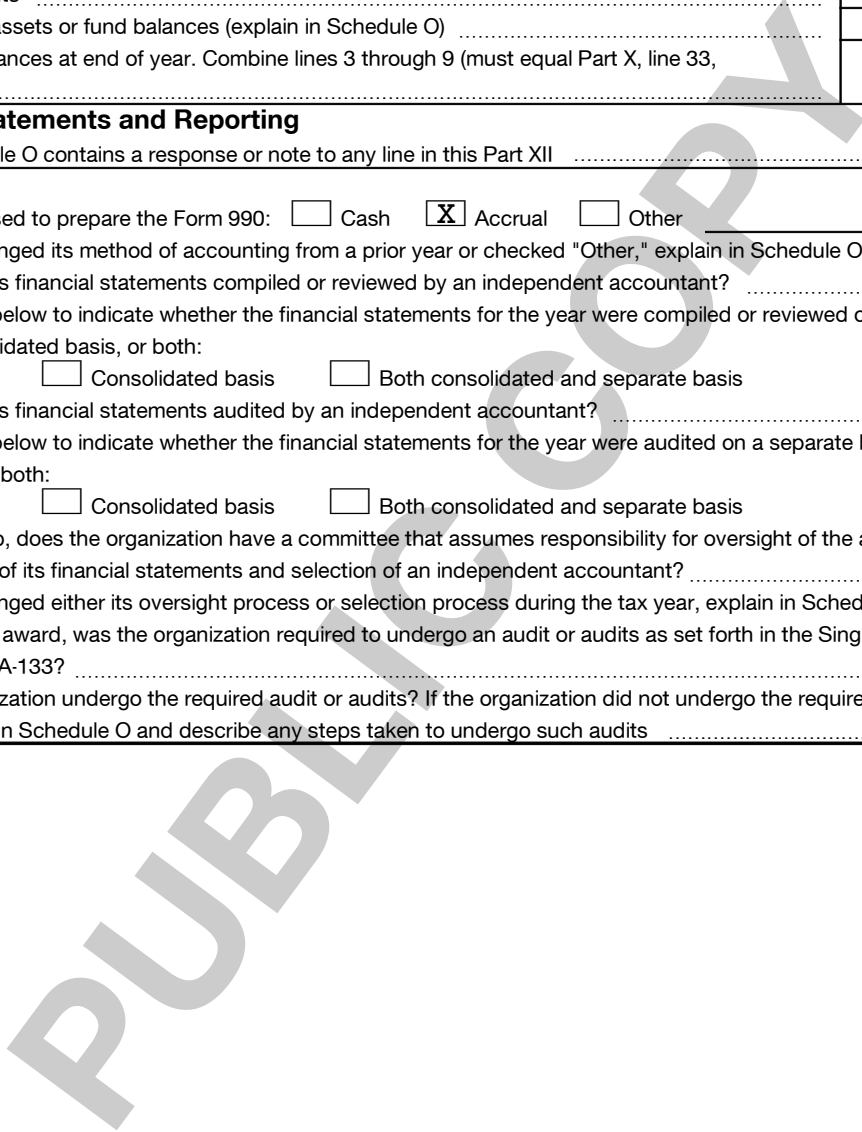

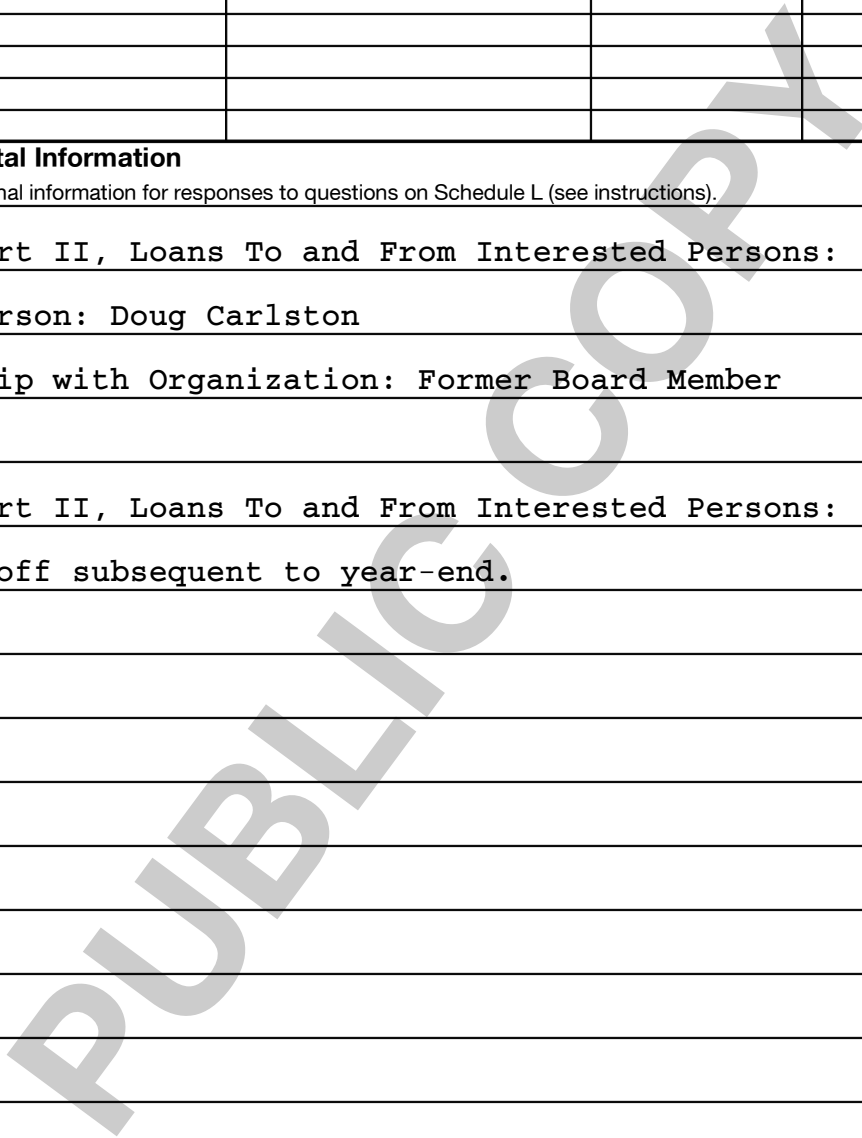

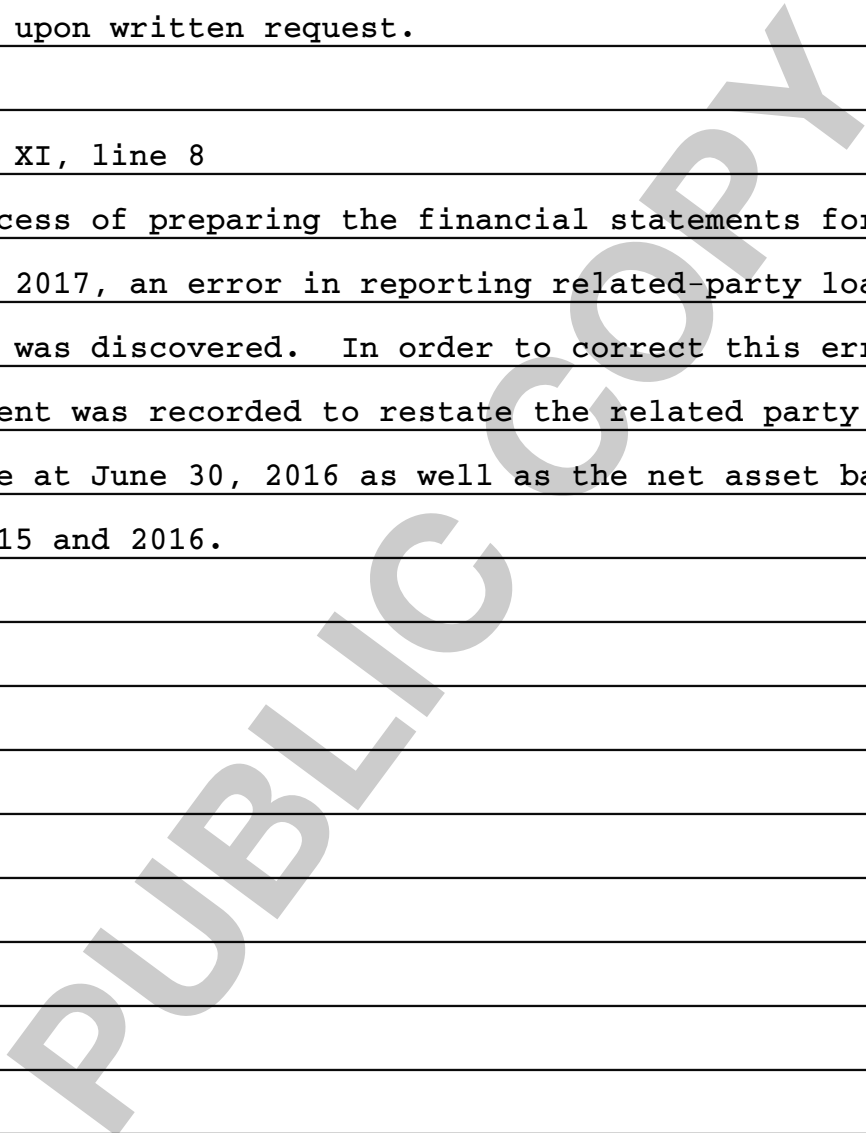
